Titanium Cargo Trailers warrants the original owner that the trailer will be free from defects in materials and workmanship for the period of three years except as herein limited, from the date of the first retail purchase, provided all stated conditions and exclusions are met and satisfied. The obligation of this warranty shall be limited to repairing or replacing any parts, which, in the opinion of Titanium Cargo Trailers are defective in materials and workmanship under normal use and service during the three-year period commencing with the date of the first retail purchase. Electrical components, lights, mechanical jacks, fiberglass, doors, sealants, seals, locks, couplers, and paint (except paint on open units) are warranted for a three-year period from the date of the first retail purchase, subject to the limitations contained in this limited warranty.

Excluded from this warranty are all items warrantied by their own manufactures such as Axles, Tires, Air Conditioners, etc. All warranty requests must be presented to Titanium Cargo Trailers and proper arrangements must be made and approved by the factory prior to any work being done. All warranty repairs must be made at the factory, unless prior written approval is obtained from the factory before said repairs begin. In certain cases, the factory may, as its option, elect to have warranty work performed in the field by a qualified repair shop. Titanium Cargo Trailers will not be obligated in any way to pay for repairs made without specific written approval in advance, repairs made in any manner other than approval. Labor charges in excess of those deemed reasonable by Titanium Cargo Trailers or any parts bills in excess of the cost if Titanium Cargo Trailers has supplied those parts. Labor and parts charges for any covered warranty work are limited to the amount charged by Titanium Cargo Trailers for such labor and/or parts. Except as described in this limited warranty, Titanium Cargo Trailers will not pay any other charges or expenses including, without implied limitations, any charges for overtime labor, service calls, towing charges, or transportation cost. Such charges or expenses are the responsibility of the customer and will not be paid for by Titanium Cargo Trailers

Any expressed or implied warranty not provided herein, including without implied limitation, any warranties of merchantability or fitness for a particular purpose, and any remedy for breach of contract, which but for this provision might arise by implication of operation law, are hereby excluded and disclaimed. If they cannot be disclaimed, any implied warranties of merchantability and of fitness for any particular purpose are expressly Limited to a term of three years. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Under no circumstance shall Titanium Cargo Trailers be liable to purchase or any other person for any special, incidental, or consequential damages, whether arising out of breach of warranty, Breach of contract Tort or otherwise. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation may not apply to you. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

Notwithstanding anything to the contrary herein, this limited warranty is limited to repair or replacement and if such warranty fails because attempts at repair are not completed within a reasonable time, or it fails for any other reason, any damages are limited to the lesser or either the cost of needed repairs or reduction in the market value price. The trailer caused by lack of repairs, in any case.

Titanium Cargo Trailers neither assumes nor authorizes any other person to give any other warranty or to assume on its behalf any other obligation or liability. Any second party changes done to this trailer, that were not done at Titanium Cargo trailers. Causes for Immediate void of warranty, and we are not held accountable for repairs of such trailer. This warranty is non-transferable from the original end user.
